BOOTH SPACE: 10' x 10' is \$25.00 plus a 10% donation of your final sales. Spaces are limited. Final placement of booth will be a committee decision.

SET UP TIME: Set up time is between 1:30 p.m. and 3:30 p.m. Breakdown is after 9:00 p.m. We want to build a quality event. Tables must be covered with a floor length tablecloth and all boxes removed or hidden from sight. Shade canopies or umbrellas are recommended for most areas. There will be no electricity available.

DESCRIPTION: Merchandise or food items to be sold (please be specific).

Food vendors must obtain a permit from Mariposa County Health Department.

THIS IS A JURIED SHOW: Vendors include 4 photographs. If you are sharing a booth, each artist must send photos. Only the types of items you jury will be allowed for sale in your booth. You will be asked to remove any items not fitting your juried category.

APPLICATIONS: Are due by July 1, 2019. Acceptance letters, placement maps and instructions will be mailed by July 15, 2019. No refunds on accepted applications. Please include a self-addressed stamped envelope.
